

**Minutes of the meeting of Seaton Ross Parish Council held on
Friday 6 December 2019**

A Parish Council meeting was held in the village hall on Friday 6 December 2019 at 7.30pm.

- 70/19 Cllr Leo Hammond** – Cllr Hammond introduced himself to the Parish Council as the new ward councillor.
- 71/19 Declarations of interest** – Cllr Johnson declared a pecuniary interest in item 72/19 and took no part in this item.
- 72/19 Rolawn Ltd, The Airfield – Consultation on addition to existing licence to keep 20 vehicles and 40 trailers at the premises** – two parishioners attended the meeting to discuss the licence application.
- Agreed that the Parish Council write to the Traffic Commission to express concerns about the increase in vehicles, the impact on residents on Mill Lane, operating hours and access to the site through Seaton Ross.**
