**142/16 Minutes – Agreed** – that the minutes of the meeting held on 24 February 2017 be approved and signed by the Chairman.

**143/16 Matters arising** –

- a. The Clerk would draft a letter and circulate to members about inconsiderate parking in the passing place on Mains Lane before sending to The Bungalow.
- b. Sale of phone box – ERYC had informed the Clerk it may be some considerable time before BT completed the transaction to sell the phone box to the Parish Council. It was unlikely this would be before Open Gardens in May.
